COMPETETION GUIDELINES

Package Contents:

- ❖ Tentative Schedule of Events Registration for ALL Competing Teams begins in person at the event grounds on Thursday, September 18th, 2025 between 8:00am and 4:00pm. At least one (1) competitor must be present to register and have identification agency identification. Participants will be required to display the provided wrist band to gain access to the training grounds during all competition. Team Members WILL NOT be allowed inside the competition zone without event identification. Immediately following registration close, a safety brief and course walk-through will take place, followed by an opening ceremony dinner banquet at 7:00pm. More information will be sent with your welcome packet.

- ❖ Waiver of Liability Form ALL team participants, including guest spectators and vendors, are required to complete and sign this form. Team forms can be turned in on the day of the event registration. Spectators turn in or sign forms at the gate.

Payment Information:

Team fees of \$600.00 is required for registration and participation in the Midwest SWAT Comp. Team fees include unlimited MO POST training course entries, catered kick-off and awards dinner, VIP area access, and full swag kit. The first **twenty-five (25) teams** to **register and pay** will be accepted and their spot reserved. Entries beyond the first twenty-five will be placed on a waiting list and notified as such.

Competition

VIP Access:

Friends and family of participants, as well as designated department heads/guests are welcome to watch the events and are permitted entrance into the VIP area which includes a catered meal for each guest for breakfast, lunch, and dinner as well as drinks throughout the event for a **fee of \$100.00**.

Team Participants:

A team consists of five (5) total members, four (4) competitors with one (1) alternate. Four (4) competitors are required for all mandatory events. All team members may alternate on any given event. Each Competitive Team Member MUST be sworn law enforcement or military. Agencies can elect to have more than one team represented in the competition.



Identification:

Each team member is required to provide official agency identification during the registration process on Thursday, September 18th, 2025. All guest spectators are all required to provide photo identification.

Equipment/Dress Code:

Teams are required to wear tactical uniform/gear, including full kit and tactical boots, NO athletic or running shoes allowed while competing. Pistol and rifle/carbine, along with ammunition are required for each member of the team. Precision rifle and ammunition required only for designated marksman. ALL members must also have their own gas mask for event purposes.

Vendors:

Various industry professionals will be in attendance and will set up booths in the designated vendor area only. Participants and guests are encouraged to visit the area frequently. A final vendor list will be posted to the website before the event.

Opening and Closing Ceremonies:

The event's open ceremony will be Thursday, September 18th, 2025 after the registration process ends. The closing ceremony on Saturday, September 20th, 2025 will begin when all scoring is finalized. Team awards and trophies will be presented during the closing ceremonies. Raffles and drawings will take place after the awards are presented.

Event Protests/Grievances:

Teams are allowed only one (1) protest/grievance during the event. All protests/grievances are required to be levied in writing, within 30 minutes of the team's completion of the event by the team's designated Team Leader only. Protests/Grievances will be reviewed by the judges panel and decisions made by the Chief Judge before the next team's event.

Teams receiving a favorable outcome from the protest/grievance process will be granted a second protest/grievance during the competition. Teams receiving an unfavorable outcome from the protest/grievance process will not have an opportunity to present any addition protest/grievance during any additional events. Team Leaders are requested to speak with the Chief Judge at the designated area only. Vendor Information



Accommodations:

Teams are encouraged to utilize our on-site lodging and equipment storage for easy access and to ensure sensitive item security, free of charge. There are several local hotels within a 15 minute drive of the facility if that option is preferred, with reasonable rates. Further information will follow in your welcome packet.

Inclement Weather Plan:

The competition will proceed rain or shine with exception of dangerous lightning within five (5) miles of the training grounds. Events will continue within the designated date range; however, competition days may be extended or events altered to accommodate delays.
